Explanation of Responses:

- The stock option will vest as to 25% of the underlying shares of Common Stock on February 11, 2021, and with respect to the remaining shares in 36 equal monthly installments thereafter.
- The stock option will vest and become exercisable with respect to 50% of the shares upon the achievement by the Issuer of a price per share that equals or exceeds \$27.41, and with respect to the remaining shares upon the achievement by the Issuer of a price per share that equals or exceeds \$36.54 between January 1, 2023 and June 30, 2023.
- The stock option will vest as to 25% of the underlying shares of Common Stock on January 6, 2022, and with respect to the remaining shares in 36 equal monthly installments thereafter.
- The stock option will vest and become exercisable upon the achievement by the Issuer of a price per share that equals or exceeds \$33.00 between January 1, 2023 and June 30, 2023.
- The stock option will vest as to 25% of the underlying shares of Common Stock on July 1, 2022, and with respect to the remaining shares in 12 equal quarterly installments thereafter.
